Jouni Torasvirta, 1965, chairman

Jouni Torasvirta has been the chairman of the company's Board of Directors since its establishment on 30 December 2010.

Torasvirta has also been a member of the Board of Directors of the management company and its CEO since its establishment in May 2009.

Torasvirta has approximately 20 years' experience in various posts in the Nasdaq OMX Group and its predecessors. At Nasdaq OMX, Torasvirta was Senior Vice President responsible for Equities Markets from March 2008 to November 2008, a member of the extended management group and the CEO of Nasdaq OMX Helsinki. At OMX, Torasvirta was President responsible for trading services from January 2006 to February 2008, a member of the Nordic management group and CEO of the OMX Nordic Exchanges Helsinki. At the OMX Exchanges Group, Torasvirta was President responsible for Cash Market Products & Cash Market Finland from September 2003 to January 2006. Torasvirta was also the CEO of the Helsinki Stock Exchange from September 2003 to January 2006. At the HEX Group, Torasvirta was, among other things, the director of marketplace and trading at the start of the 2000s, a member of the Group's management group and the business director of Securities Services.
